The Pacific Multi-Asset Accumulator Core Strategy will have a balance of capital protection and equity market exposure.

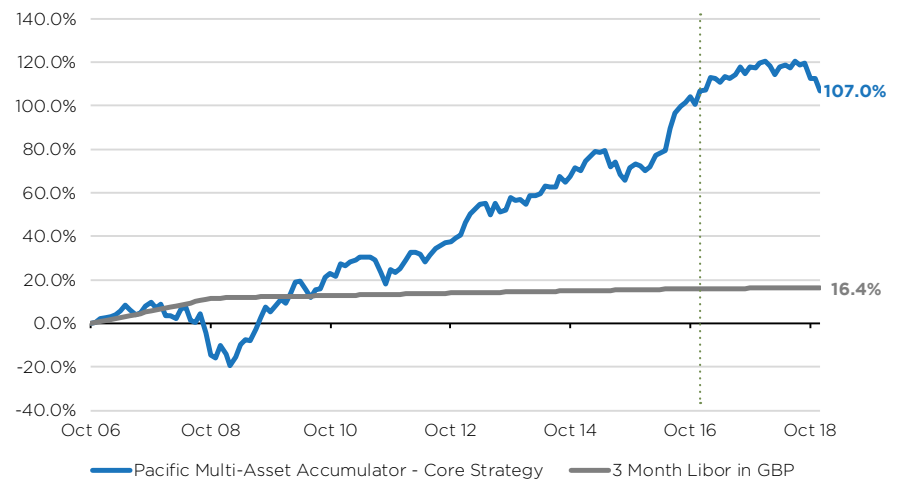
Investment strategy

A blended approach combining active, passive and direct investments across a diversified, global mix of assets classes including equities, fixed income, alternatives, diversifying assets and cash. A significant allocation of assets will be invested in UK and global equities looking to capture the capital growth potential offered by an allocation to equities. The strategy may also have significant exposure to fixed income securities including government, corporate and emerging market bonds to help protect capital and provide income. The remainder of assets will be in diversifying asset strategies looking to generate positive returns with limited correlation to traditional asset classes e.g. bonds and equities.

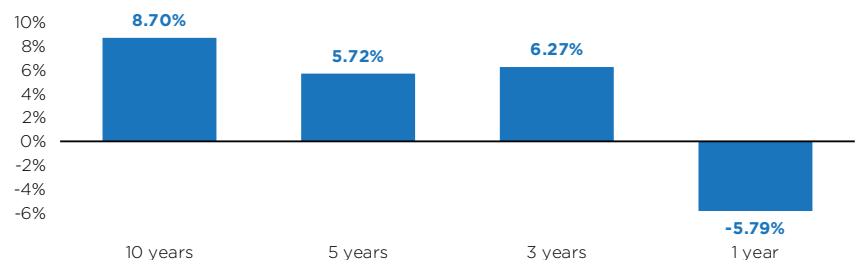
Strategy performance

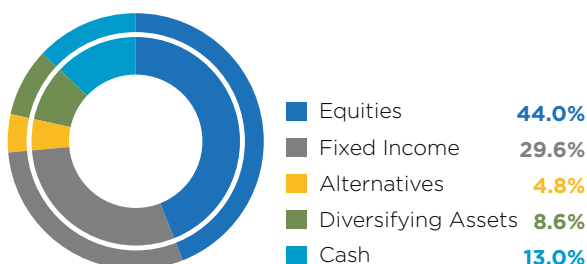

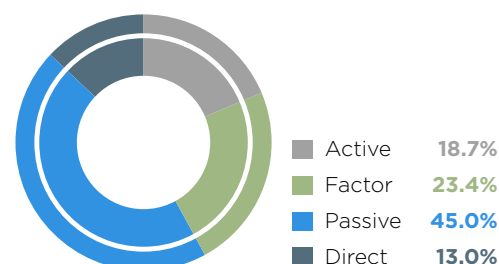
