What is this product?

Type

Term

The Company is an open-ended fund with no specified maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIPs Manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

Objectives

The investment objective of the Product is to achieve long-term capital appreciation. The Product is considered to be actively managed, which means that the Sub-Investment Manager is not constrained by any index or benchmark in the selection of investments. The performance of this Product is measured against the MSCI Emerging Markets Gross Total Return Index (in the currency of the Class) for the purposes of the calculation of performance fees for the Class. The Product does not intend to track this index. This index was chosen because it represents the minimum level of return that is expected from the Product over the stated time period. The majority of the Product will not be components of the index. The Product seeks to achieve this objective through investing primarily in equity and equity related securities (such as warrants and rights issues) of companies listed on or dealt in Recognised Markets in emerging markets or which are listed on or dealt in Recognised Markets outside of the emerging markets but which generate the bulk of their earnings in emerging markets. The Product will only take long positions for investment purposes. The maximum anticipated long exposure of the Product is 115% of its Net Asset Value (100% direct investment and 15% leveraged exposure). The Product may take short exposures for hedging purposes only and the maximum anticipated exposure in this regard is 20% of its Net Asset Value. The Base Currency of

the Product is US Dollar. The investment team combines top-down analysis and bottom up company research in order to build a portfolio of liquid and diversified holdings. The Product's investments will have no industrial or sectoral focus. The Product may use derivatives for investment purposes and / or efficient portfolio management purposes. Further information in respect of the Product's use of derivatives is set out in the Derivatives section of the Product's Supplement. The Product may enter in to Repurchase Agreements and Reverse Repurchase Agreements, and Stocklending Agreements for the purpose of efficient portfolio management.

Intended Retail Investor

This Product is intended for investors who understand the degree of risk, who can tolerate a medium level of volatility and who are able to bear any losses (which may equal the whole amount invested) that may result from an investment in the Product. The Product is designed to form part of a portfolio of investments.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Performance Scenarios

What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company has no obligation to pay out since the Company design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should the Company default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product.
